ECONOMIC OUTLOOK

MARKET

- **Vacancy Rate:** Increased by 23 bps in Q3 to 3.5%.
- **Net Absorption:** Declined in Q3 totaling -171,276 SF.
- **Rental Rates:** Declined by \$0.03 PSF or 2.5% to a rate of \$1.18 PSF NNN in Q3.
- **Sales:** The median price PSF was down in Q3 to \$251.05. Volume declined 21.7% from Q2 totaling \$39.5M in Q3. The largest sale of Q3 was 14399 Princeton Ave in Moorpark which sold for \$13.7M or \$298.37 PSF.

ECONOMIC OUTLOOK

- **Interest Rates:** In July, the FOMC decided to hike interest rates 25bps to a target range of 5.25% - 5.50%. At the September meeting, the FOMC decided to pause & maintain rates at the current level. FOMC members anticipate at least one more hike to occur in 2023. The 10 Year Treasury is currently at its highest rate since 2007 given the increased economic anxiety.
- **Inflation:** Headline CPI increased in the latest August report largely due to gasoline prices. CPI remains well above the Fed's 2% target rate.
- **Supply Chain:** The cost from China/East Asia to North America West Coast increased 41.5% over Q3, ending at \$1,687 per container. (Freightos)

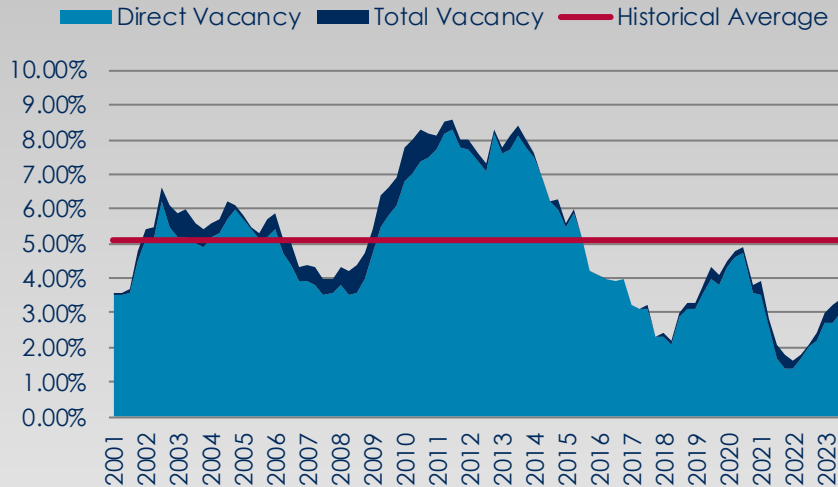

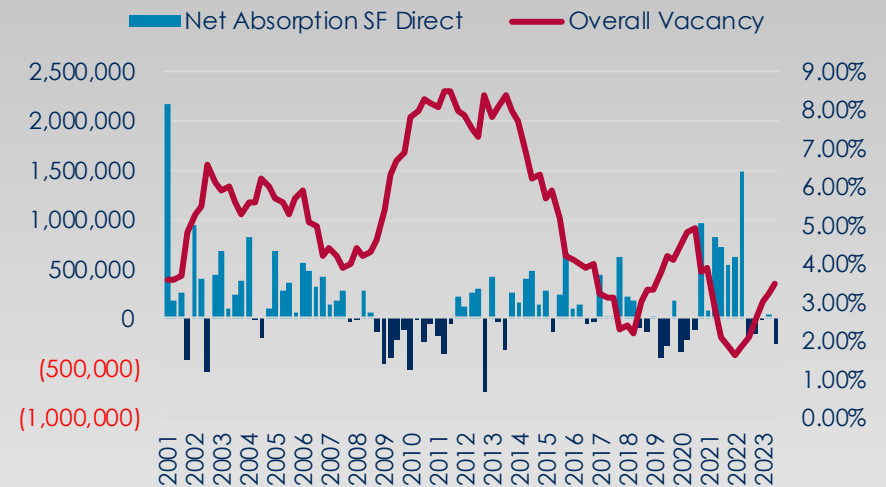

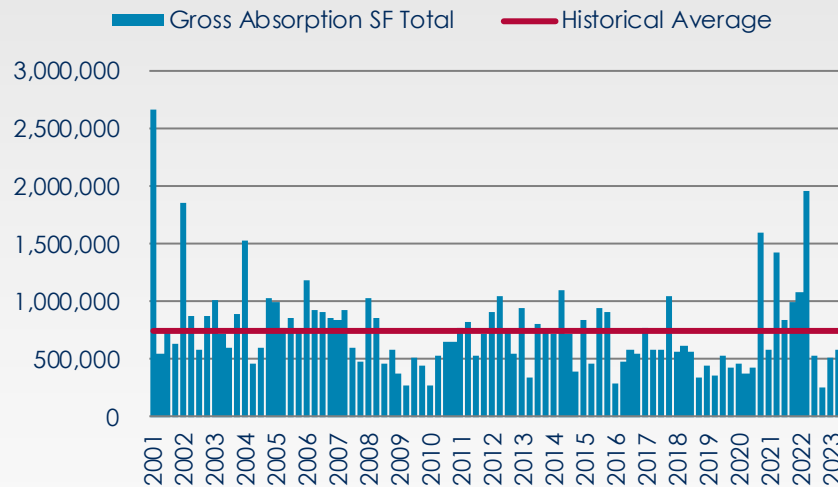
OVERALL VACANCY INCREASED 23 BPS FROM Q2 TO 3.5% IN Q3



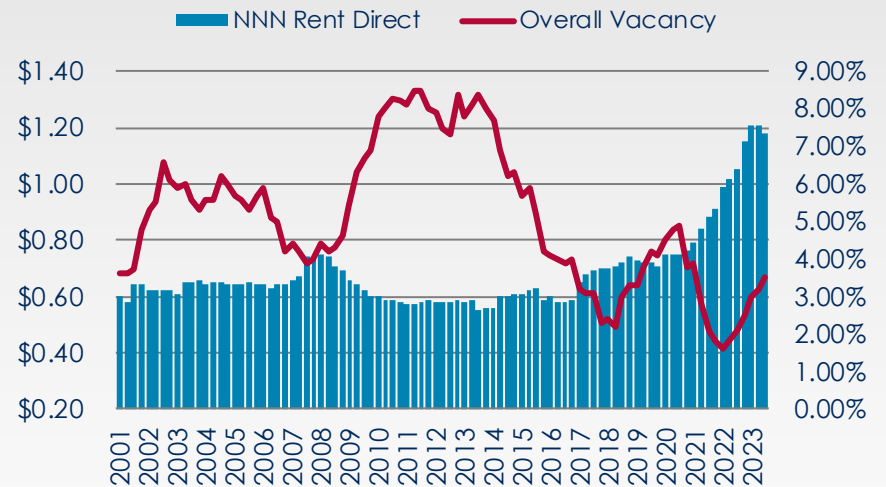
NET ABSORPTION REMAINED NEGATIVE OVERALL IN Q3 TOTALING -171K SF



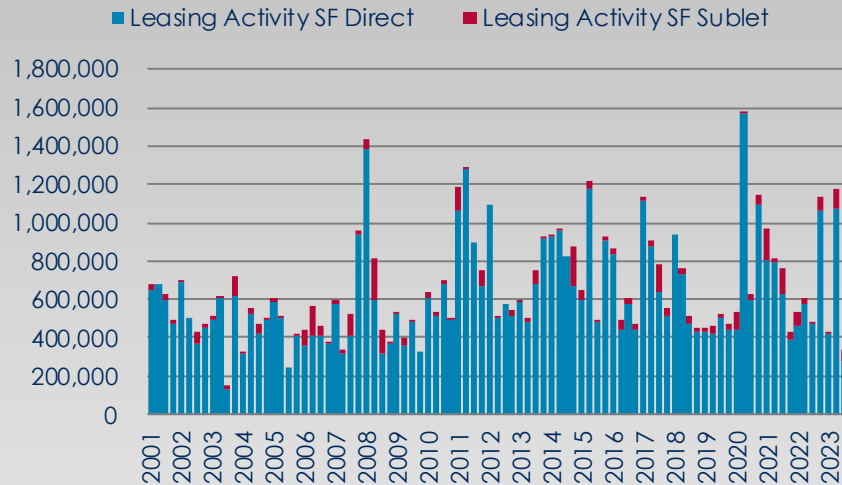
GROSS ABSORPTION DECLINED 6.1% FROM Q2 TO 547K SF IN Q3



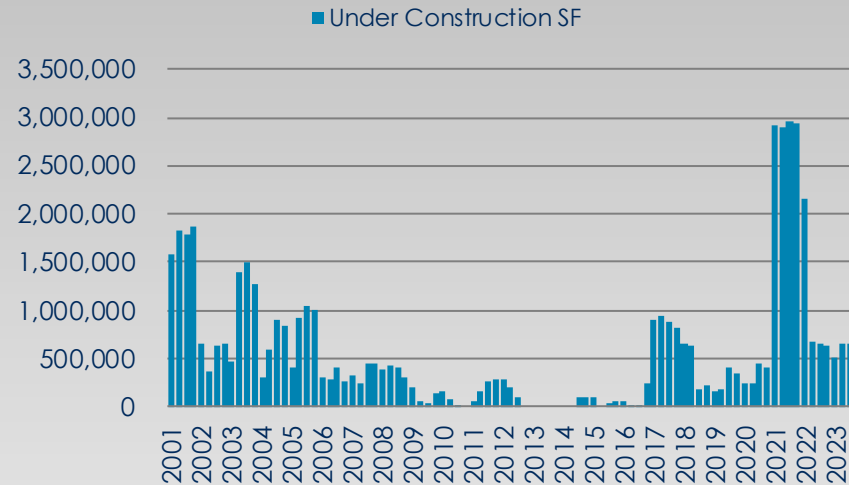
ASKING RENTS DECLINED BY \$0.03 OR 2.5% IN Q3 TO \$1.18 PSF



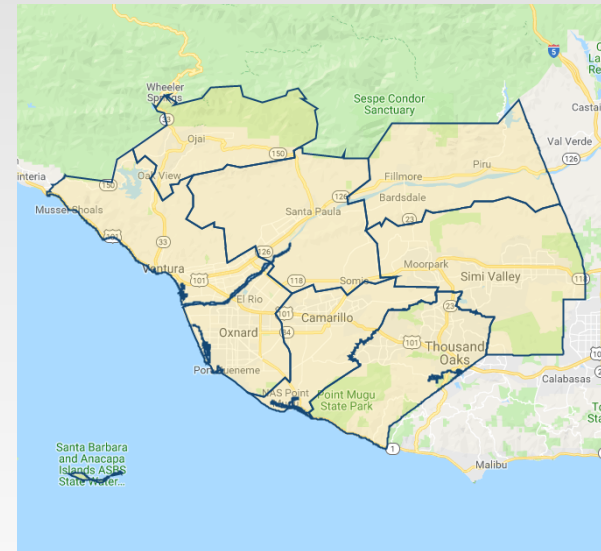
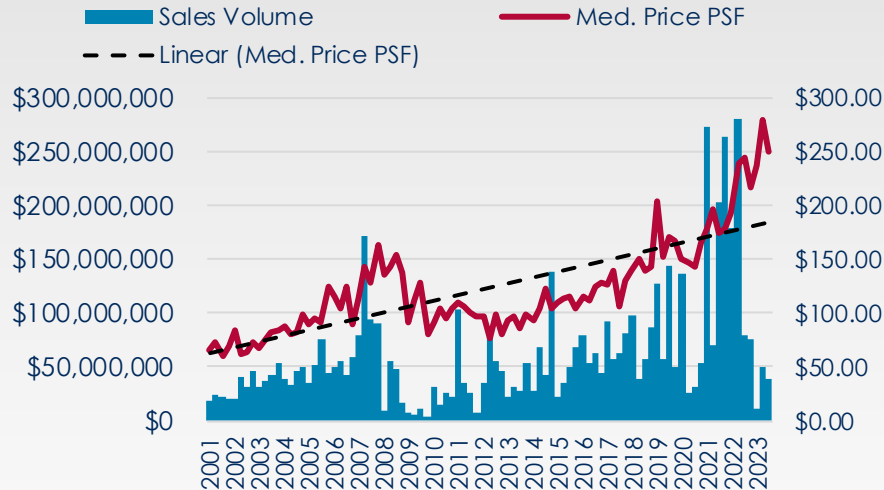

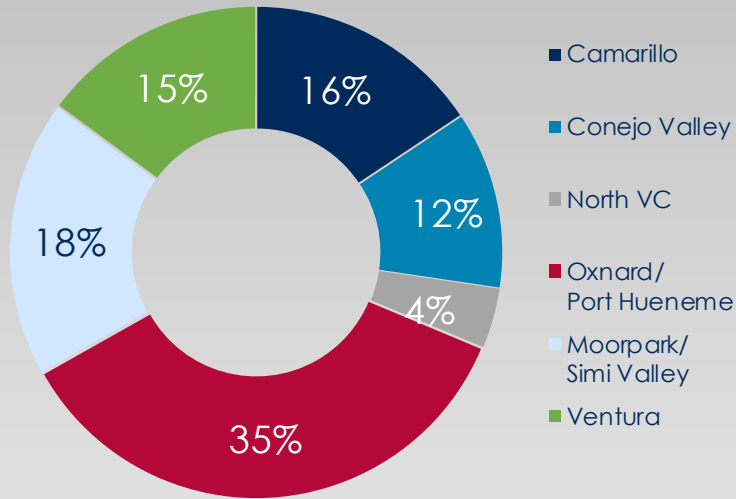
CONSTRUCTION ACTIVITY NO DELIVERIES IN Q3. UC REMAINS AT 660K SF



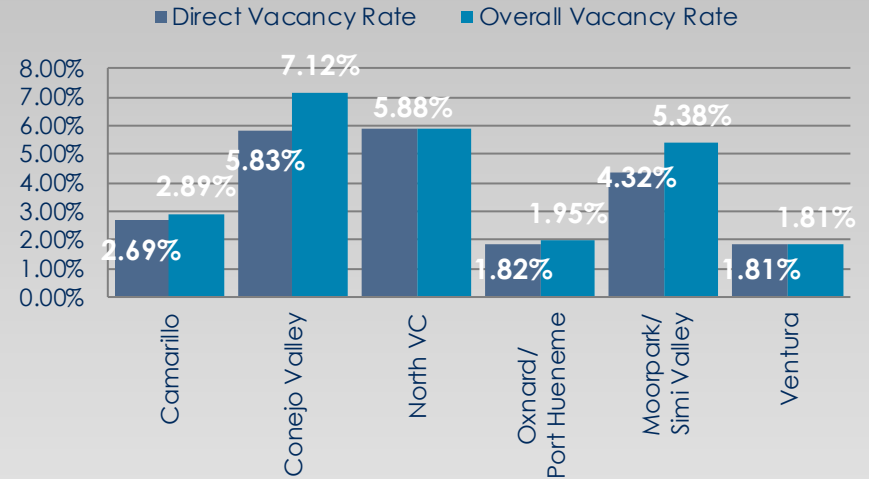

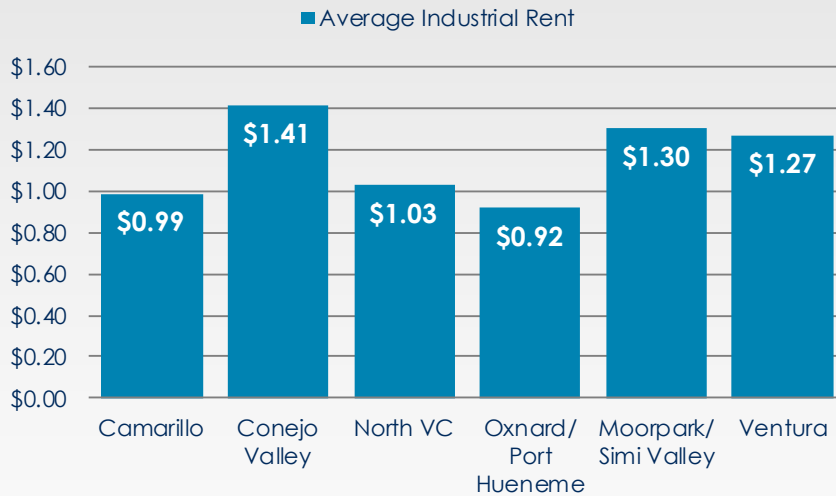
SQUARE FOOT BREAKDOWN- 73,845,267 SF MARKET SIZE



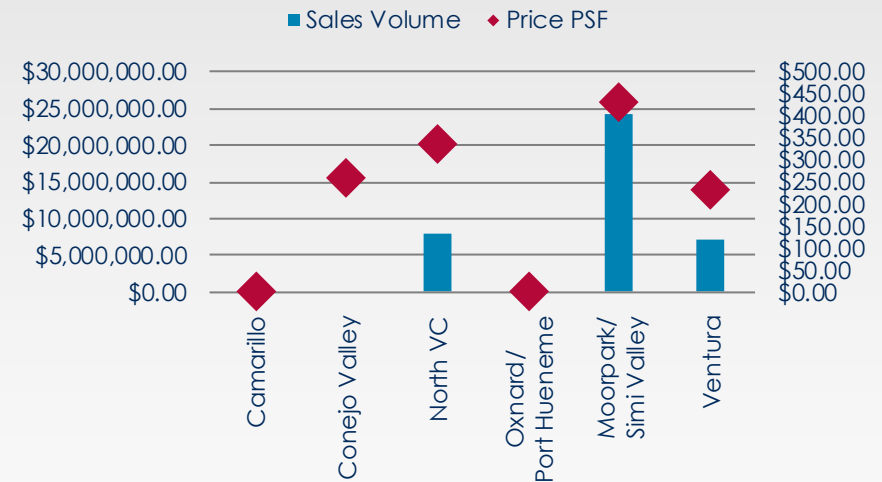
VACANCY BREAKDOWN

METHODOLOGY & TERMINOLOGY

Methodology

Industrial and flex (R & D) buildings that are 5,000 square feet and greater.

Direct Vacant SF

Space that is vacant and ready for occupancy by a user. The space is being offered for lease or sale directly from the landlord.

Total Vacant W/ Sublet SF

Space that is vacant and ready for occupancy by a user. The space is being offered for lease or sale by the landlord or for sublease by the current tenant.

Direct Vacancy Rate

Total vacant direct space (vacant space for lease or sale from the landlord or owner) divided by the total rentable square footage for existing buildings only.

Vacancy W/ Sublet Rate

Total vacant direct space and sublease space divided by the total rentable square footage for existing buildings only.

Gross Absorption

The total change in occupied space over a given period of time, counting space that is occupied but not space that is vacated by tenants. Gross absorption differs from leasing activity, which is the sum of all space leased over a certain period of time.

Net Absorption

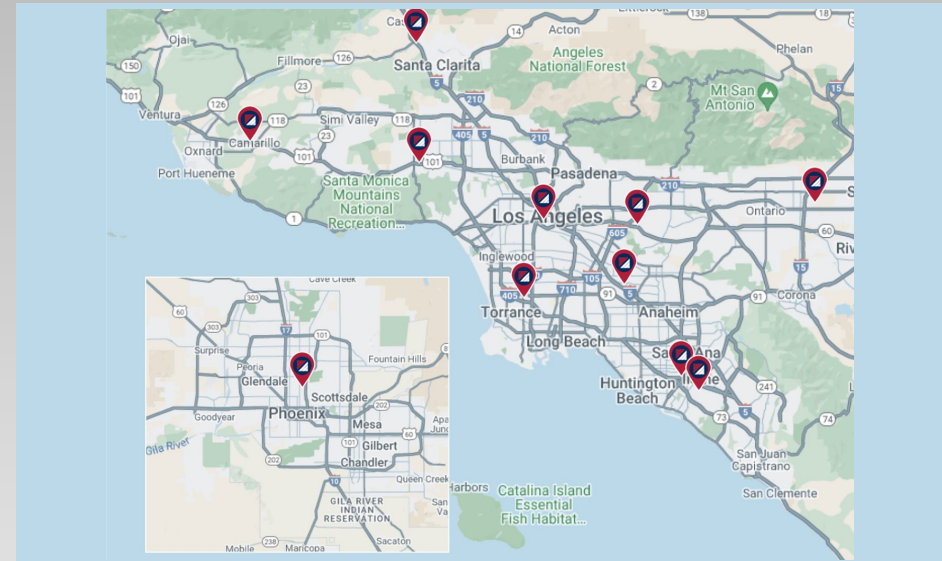
The net change in occupied space over a given period of time, calculated by summing all the positive changes in occupancy (move ins) and subtracting all the negative changes in occupancy (move outs).

Under Construction

Planned buildings for which construction has started but have not yet been granted a Certificate of Occupancy. Planned buildings are not included.

Completed in 2023

New buildings with original construction completed in the year 2023 and granted a Certificate of Occupancy. Renovated buildings are not included.

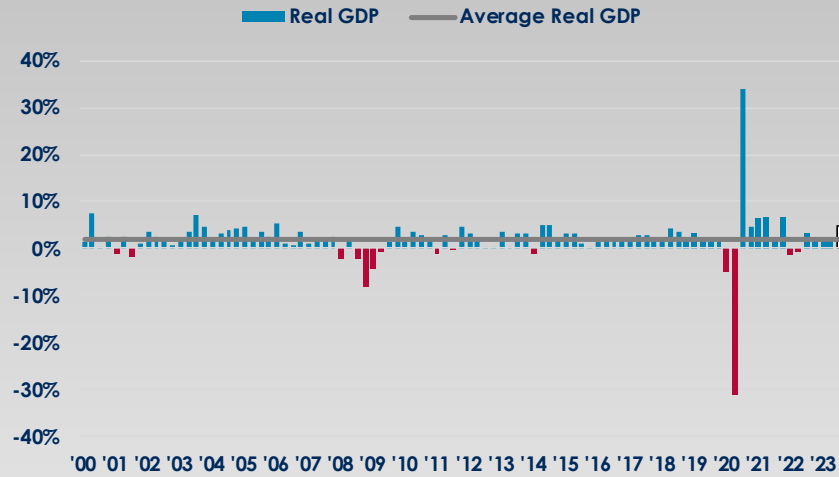

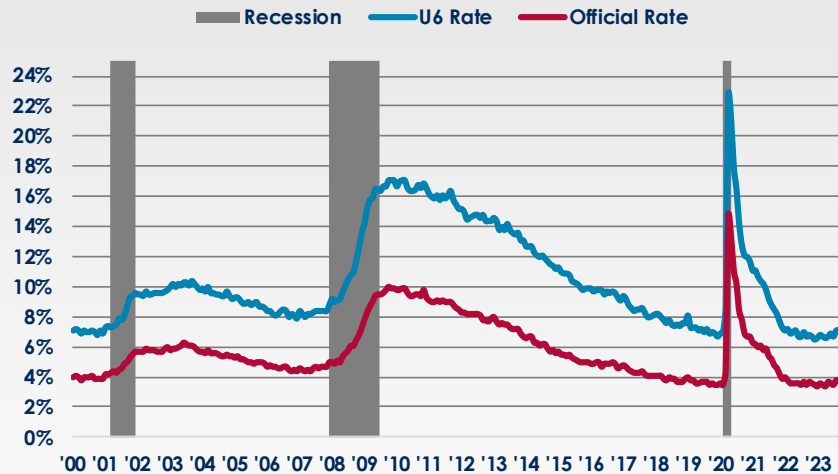

GDP IN Q2 FINISHED AT 2.1%. Q3 ESTIMATE AT 4.9% PER GDPNOW

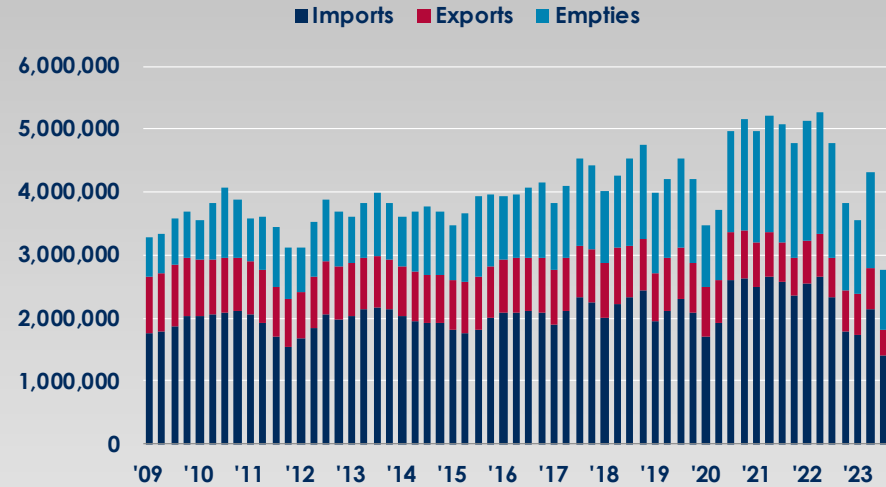

UNEMPLOYMENT CONTINUES TO BE STICKY IN Q3

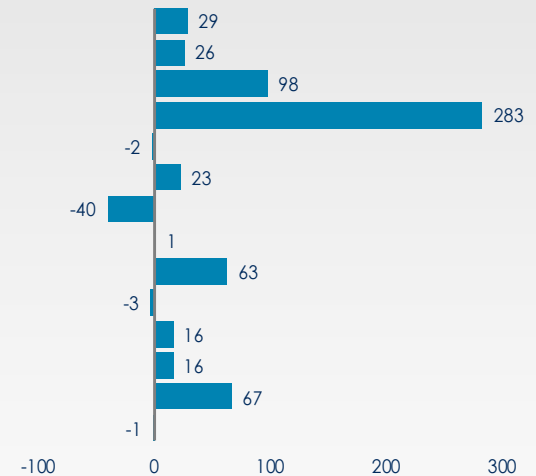

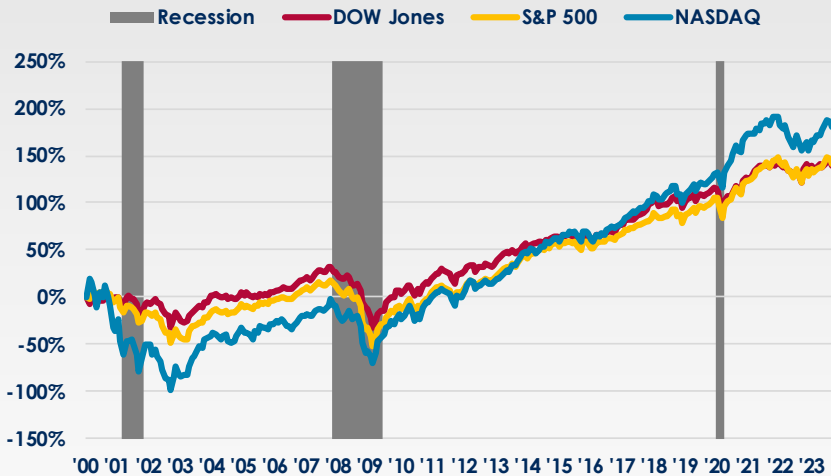
INCREASE IN GAS PRICES PUSHED CPI HIGHER IN LATEST AUG. REPORT
