#### KEY TAKE AWAYS

#### MARKET

- Vacancy Rate: Increased by 68 bps from Q2 to a rate of 11.7% in Q3. Sublet space up to 4.6M SF.
- Net Absorption: Weaker in Q3, totaling 1.9M SF. Representing 0.41% of inventory.
- Industrial Supply: 5.6M SF was delivered in Q3. Under construction was revised to 28.2M SF, representing 6.1% of inventory.
- Sales: The median price PSF in Q3 was \$193.36. Volume in Q3 was up 30.2% to \$1.1B. The largest single building sale was Building B at The Cubes in Glendale. A 1.2M SF building leased to Amazon sold for \$128.1M at \$106.74 PSF.

#### **ECONOMIC OUTLOOK**

- Interest Rates: At the September meeting, the FOMC decided to cut rates by 50 bps ending the historic rate hike cycle. The average 30-Yr. mortgage rate fell to lowest level in two years. In Q3, the 10-2Yr. yield curve disinverted. A historical indicator of a coming recession.
- Inflation: CPI continues to be elevated above the Fed's 2% target, but gradually improving.
- Supply Chain: YTD Y/Y volume at the San Pedro Port Complex is up 19.5%. The cost from China/East Asia to North America West Coast declined 3.3% over Q3, ending at \$6,816 per container. (Freightos). Continued Middle East tensions and labor strikes at East Coast ports could impact future pricing.









### OVERALL VACANCY INCREASED BY 68 BPS FROM Q2 TO 11.7% IN Q3




### GROSS ABORPTION DECLINED 15% FROM REVISED Q2 TO 8.5M SF IN Q3



### NET ABSORPTION WEAKER DEMAND IN Q3 TOTALING 1.9M SF




### ASKING RENTS INCREASED BY \$0.01 PSF OR 1.0% FROM Q2 TO \$1.06 PSF IN Q3







### METHODOLOGY & TERMINOLOGY

#### Methodology

Industrial and flex (R & D) buildings that are 5,000 square feet and greater.

#### **Direct Vacant SF**

Space that is vacant and ready for occupancy by a user. The space is being offered for lease or sale directly from the landlord.

#### Total Vacant W/ Sublet SF

Space that is vacant and ready for occupancy by a user. The space is being offered for lease or sale by the landlord or for sublease by the current tenant.

#### **Direct Vacancy Rate**

Total vacant direct space (vacant space for lease or sale from the landlord or owner) divided by the total rentable square footage for existing buildings only.

#### Vacancy W/ Sublet Rate

Total vacant direct space and sublease space divided by the total rentable square footage for existing buildings only.

#### **Gross Absorption**

The total change in occupied space over a given period of time, counting space that is occupied but not space that is vacated by tenants. Gross absorption differs from leasing activity, which is the sum of all space leased over a certain period of time.

#### **Net Absorption**


The net change in occupied space over a given period of time, calculated by summing all the positive changes in occupancy (move ins) and subtracting all the negative changes in occupancy (move outs).

#### **Under Construction**

Planned buildings for which construction has started but have not yet been granted a Certificate of Occupancy. Planned buildings are not included.

#### Completed in 2024

New buildings with original construction completed in the year 2024 and granted a Certificate of Occupancy. Renovated buildings are not included



#### GDP IN Q2 FINISHED AT 3.0%. Q3 ESTIMATE AT 2.5% PER GDPNOW




#### LABOR MARKET SHOWING SIGNS OF SOFTENING



#### PORT ACTIVITY IN Q2 WAS UP 7.6% Y/Y. YTD UP 19.5% Y/Y




#### EDUCATION & HEALTH SERVICES LED JOB GAINS AGAIN IN Q3




