
#### MARKET

- Vacancy Rate: Increased 19 bps in Q1 to 5.51%. Year over Year has increased 149 bps.
- Net Absorption: Remains negative, but improved from Q4 totaling -561,910 SF in Q1.
- Asking Rents: Declined by \$0.02 PSF or 1.3% in Q1 to a rate of \$1.57 PSF NNN.
- Industrial Supply: 317K SF was delivered in Q1. Under construction expanded to 2.68M SF.
- Sales: The median price PSF in Q1 was \$360.00. Volume in Q1 totaled \$446.7M; up 29% from Q4.

#### ECONOMIC OUTLOOK

- Interest Rates: At both the January & March meetings, the FOMC decided hold rates at 4.25-4.50%. FOMC members are only projecting two 25 bps cuts to occur in 2025.
- Supply Chain: YTD Y/Y volume at the San Pedro Port Complex is up 15.3%. The cost from China/East Asia to North America West Coast declined 63% over Q1, ending at \$2,187 per container. (Freightos). Newly announced sweeping tariffs aimed at resetting global trade will potentially have a significant impact on businesses and consumers. To avoid the impact of the tariffs, businesses may decide to onshore manufacturing. A positive sign for the industrial real estate sector.



#### OVERALL VACANCY INCREASED BY 19 BPS IN Q1 TO 5.51%




#### GROSS ABORPTION INCREASED BY 28.2% FROM Q4 TO 3.2M SF IN Q1





#### NET ABSORPTION REMAINS NEGATIVE IN Q1 TOTALING -562K SF





#### ASKING RENTS DECLINED BY \$0.02 PSF OR 1.3% IN Q1 TO \$1.57 PSF NNN





#### LEASING ACTIVITY DECLINED BY 18.9% FROM REVISED Q4 TOTALING 2.95M SF IN Q1











#### CONSTRUCTION ACTIVITY 317K SF WAS DELIVERED IN Q1. UC EXPANDS TO 2.68M SF











#### VACANCY BREAKDOWN




#### AVERAGE ASKING RENT PSF NNN AT CLOSE OF QUARTER

#### METHODOLOGY & TERMINOLOGY

#### Methodology

Industrial and flex (R & D) buildings that are 5,000 square feet and greater.

#### **Direct Vacant SF**

Space that is vacant and ready for occupancy by a user. The space is being offered for lease or sale directly from the landlord.

#### Total Vacant W/ Sublet SF

Space that is vacant and ready for occupancy by a user. The space is being offered for lease or sale by the landlord or for sublease by the current tenant.

#### **Direct Vacancy Rate**

Total vacant direct space (vacant space for lease or sale from the landlord or owner) divided by the total rentable square footage for existing buildings only.

#### Vacancy W/ Sublet Rate

Total vacant direct space and sublease space divided by the total rentable square footage for existing buildings only.

#### Gross Absorption

The total change in occupied space over a given period of time, counting space that is occupied but not space that is vacated by tenants. Gross absorption differs from leasing activity, which is the sum of all space leased over a certain period of time.

#### **Net Absorption**


The net change in occupied space over a given period of time, calculated by summing all the positive changes in occupancy (move ins) and subtracting all the negative changes in occupancy (move outs).

#### **Under Construction**

Planned buildings for which construction has started but have not yet been granted a Certificate of Occupancy. Planned buildings are not included.

#### Completed in 2025


New buildings with original construction completed in the year 2025 and granted a Certificate of Occupancy. Renovated buildings are not included






#### GDP IN Q4 FINISHED AT 2.4%. Q1 ESTIMATE AT -3.7% PER GDPNOW








#### EDUCATION & HEALTH SERVICES LED JOB GAINS AGAIN IN Q1








#### THE FED HELD RATES IN JAN & MARCH. 10 YR DOWN 35 BPS IN Q1




#### THE MAJOR INDEXES WERE DOWN AN AVERAGE OF 5.4% IN Q1
